

# Newsletter – August 2021

#### **Parish Council**

Meetings are normally held on the second Monday of each month at the **new starting time of 7pm** at the Sobey Suite of the Shurdington Community Centre and residents are welcome to attend.

The council has decided in January 2021 to increase its parish portion from your council tax bill by 3% for the current tax year (2021/22), which will be approximately 82p per annum based on a household in Council Tax Band D.

Parish Council funds are used to pay for cutting grass on The Green, to support village organisations such as the Scouts, Playgroup, Friendship Club, and the Taxi Voucher Scheme, to contribute to other organisations' expenses such as maintenance of the Churchyard, and for various items such as notices, litter bins, dog bins and bus shelters. We have set aside a special Covid fund to help the village recover from the pandemic.

#### **Last Print Edition of the Parish Newsletter**

Shurdington Parish Council are looking at ways of reducing our carbon footprint and have decided to no longer print the 6 monthly newsletter. This will save on printing and delivery costs.

The newsletter will be available digitally and will be available to download from our website.

#### Walking in Shurdington

Shurdington Parish Council continue to receive enquiries about access and the condition of footpaths in the parish. The network of paths is known as the Public Rights of Way (PROW), they are open to everyone at any time and give you the right to walk, ride a horse or cycle along certain routes. Some rights of way are open to vehicles.

Gloucestershire County Council (GCC) are responsible for the management and maintenance of this network, although landowners have a degree of responsibility for the safe unrestricted passage of all users.

Shurdington Parish Council strongly support unrestricted access on the PROW network and regularly liaise with the GCC team to ensure this is possible.

#### **Taxi Voucher Scheme**

Shurdington Parish Council operate a taxi voucher scheme for residents of the parish who find it difficult to use public transport services. This could be because of medical conditions, mobility problems or the distance to the nearest bus stop.

The scheme continues to be well used by some residents of the parish but recently we have seen a reduction of the number of vouchers being used due to the pandemic.

#### **Police Matters**

If you are a victim of crime, no matter how minor you may think it is, please report it on 101 and you will be given an incident number which you may need to use for an insurance claim. This also records crimes in our area and allows the police to judge the amount of policing we need. The Parish Council are aware that calling 101 can be time consuming, non-urgent matters can be reported to the police by emailing 101@gloucestershire.pnn.police.uk however we would ALWAYS advise that you DIAL 999 IN AN EMERGENCY.

### Gloucestershire County Council "Report It" for Highways Matters

If a highways issue poses an immediate danger to public safety please call our emergency number 08000 514 514. Emergency highways issues are classed as follows:

Objects on the highway network (i.e. a fallen tree)
Faulty temporary or permanent traffic lights (i.e. stuck on red)
Exposed cables
Multiple street lighting faults
Flooded roads
Potholes over 75mm deep

For non-emergency defects on the highway, GCC are asking us to report it via their website using their interactive mapping system, the link to this feature is:

You can report an issue related to: potholes; lights, signals and signs; damage to pavement or kerb; road markings and stud issues trees, hedges and vegetation; drainage and flooding; spillages or obstructions on the road and PROW - public footpaths & bridleways (not pavements).

### **Community Speedwatch - Volunteers Required**

Shurdington Parish Councillors would like to establish if there is enough local support to consider facilitating a Shurdington Community Speedwatch Group. At Parish Council meetings a regular source of complaints we receive are linked with speeding traffic through the village.

Volunteers would have to commit to spending time monitoring speed of traffic and collating information which could be provided to the Local Neighbourhood Police team.

All volunteers would be required to receive suitable training.

There is a securely fenced car park to the rear of the Century Hall, which may be used by carriers of expensive equipment such as catering or disco.
